Dear JNRD Contributor(s): Thank you for submitting your contribution for publication to the **Journal of Natural Resources and Development**. In order to expedite the publishing process we need to have the following copyright transfer agreement signed by at least one of the Authors who has obtained the asset of the co-author(s) where applicable. If the Authors are employed and prepared their articles as a part of their job, the rights to the Contribution initially rest with their employer. In that case, when the undersigned signs the copyright transfer agreement, the JNRD assumes the undersigned is authorized to do so by his/her employer and his/her employer has consented to all the terms and conditions of this agreement:

- The copyright to the Contribution identified above, if published in the Publication, is hereby irrevocably transferred to the Center of Natural Resources and Development (the "Publisher"). The copyright transfer covers the full and exclusive rights comprised in the copyright in and to the Contribution, including but not limited to the right to publish, republish, transmit, sell, distribute and otherwise use the Contribution and the material contained therein in electronic editions of the JNRD and all derivative works therefrom throughout the world, in all languages and in all media of expression now known or later developed, and to license or permit other to do so.
- Notwithstanding the above, the Contributor retains all proprietary rights other than copyright, such as patent rights, in any process, procedure or article of manufacture described in the Contribution.
- The publisher grants back to the Contributor the following rights:

The undersigned declares that statements given in the Contribution are the expression of the Authors. Responsibility for the content of the Contribution rests upon the Authors, not Center of Natural Resources and Development.
